

1. The company KRITIKES AEROPORIKES EKMETALLEFSEIS AEROPORIKI KAI EMPORIKI ANONYMI ETAIREIA, under the trade name SKY EXPRESS S.A. (hereinafter referred to as the "Organizer"), is organizing a promotional activity (hereinafter referred to as the "Promotion") in accordance with the following terms of participation (hereinafter referred to as the "Terms"), under which the Giveaway Prize will be awarded, as defined in these Terms. These Terms are posted on the Organizer's website <https://www.skyexpress.com> and will remain available and updated throughout the duration of the Promotion until the winners of the draw are announced, as part of this Promotion. Interested parties who wish to participate in the Promotion are advised to carefully read the Terms of Participation. Participation in the Promotion constitutes explicit acceptance of the following Terms of Participation.
2. Duration: The Promotion will run from February 12, 2025, until February 17, 2025, at 23:59. Any entries submitted after the end of the Promotion will be automatically considered invalid.
3. Eligibility: Only natural persons who have reached the age of eighteen (18) and have full legal capacity under Greek law are eligible to participate in the draws of this Promotion. Employees (whether under an employment contract or otherwise) of the Organizer or companies belonging to the same corporate group as the Organizer, as well as their first- and second-degree relatives, are not eligible to participate in the Promotion. Also excluded from participation are individuals involved in the management of the promotional activity and their first- and second-degree relatives. The Organizer reserves the right to verify the validity of entries and to automatically disqualify any entries that do not comply with these Terms or participants who attempt to interfere unlawfully with the participation process. The Organizer may also exclude participants whose participation, at its sole discretion, violates legal provisions, is made in bad faith, is abusive, or contradicts good faith and fair business practices.
4. Draw: The draw to determine the winners will take place on February 18, 2025, at 16:00, at the Organizer's offices, located on the 1st floor of Building 48, at Eleftherios Venizelos Airport. The Organizer reserves the right to reschedule the draw date by making an announcement on the Promotion's webpage on the Organizer's website. The draw will be conducted using an automated system and software that ensures the integrity of the process and the absence of human intervention.
5. Participation Process: Each interested party must be at least 18 years old and follow the steps below to participate in the Contest Promotion: Complete all required fields and accept the terms of participation in the form available on the dedicated SKY express participation page. Upon completing the registration and accepting the Terms of Participation, the participant will be automatically entered into the list of entries for the Promotion's draw. Only one entry per person is allowed. If a participant is selected as a winner in one draw, they will automatically be excluded from any future draws of the Promotion. The winner will be notified via the email address used for their registration in the Contest.

6. Prize: The prize consists of one round-trip ticket for two people per winner, valid for all destinations within the Organizer's network. A total of five (5) lucky winners will receive this prize. Each of the five (5) winners may redeem their prize exclusively between March 1, 2025, and December 31, 2025, subject to flight and seat availability, and only for the SKY joy or SKY Basic fare (depending on the destination). The winner is responsible for paying the applicable airport taxes. Following the draw, the Organizer will send an email to each winner, who must accept the prize by February 23, 2025, at 23:59. If the Organizer is unable to contact a winner by this deadline, it will reach out to the next eligible runner-up. The following clarifications apply: The Organizer bears no responsibility for any reason preventing the winner from redeeming the prize. Participation in the Promotion and the awarded prize are strictly personal and non-transferable and cannot be exchanged or redeemed in any other way except through their designated use according to these terms. If a winner refuses or fails to claim the prize within the specified timeframe, the Organizer assumes no responsibility for awarding the prize to that winner. The Organizer is not liable for any cancellations, delays, or force majeure events (including, but not limited to, strikes, adverse weather conditions, riots, public health and safety measures, terrorist attacks, etc.).
7. As part of this Promotion, the Organizer, acting as the Data Controller, collects, stores, and processes the personal data of Participants, specifically their identification and contact details, to the extent necessary for the execution of the Promotion and exclusively for purposes related to its administration. The Organizer takes all necessary measures to ensure the lawful and fair collection and processing of personal data, as well as their secure storage, in compliance with the General Data Protection Regulation (GDPR) 2016/679, Law 4624/2019, and the applicable regulatory framework.
8. Participants have the right to access their personal data, request the correction of any inaccurate personal data or its completion, and, if the regulatory framework conditions are met, exercise the following rights: erasure, restriction of processing, data portability, objection to processing, and the right to human intervention in automated decision-making processes. To exercise these rights, participants may submit a written request to the Data Protection Officer (DPO) either by physical mail or by email at callcenter@skyexpress.com. If participants believe that their personal data protection rights have been violated, they may also file a complaint with the Data Protection Authority, if they wish.
9. The Organizer reserves the right to unilaterally modify these terms, postpone, cancel, or revoke the Promotion. The Organizer may also modify or revoke the Promotion, change its scheduled dates, or amend any other term, including replacing the prizes offered with others of equal value, altering the method of prize distribution, and adjusting the number of prizes. Any such changes will be announced before they take effect. These modifications will be communicated to the public before taking effect via the Organizer's website (<https://www.skyexpress.com>), with their validity starting from the date of the corresponding update. Additionally, the Organizer may terminate the

Promotion without prior notice for reasons of public interest, force majeure, or any other significant reason.

10. Participation in the Promotion requires that participants have internet access through their own technical means. The Organizer bears no responsibility in cases where, due to circumstances beyond its control or due to force majeure (such as, but not limited to, issues or technical malfunctions of telephone networks or lines, online computer systems, servers or providers, computer hardware, software, failure to send or receive data due to lack of available space, technical issues or internet congestion, interruptions in internet connections, computer viruses, malicious or illegal actions by third parties, or fraudulent activities), the submission of entries or messages by participants is delayed or fails, or the electronic records related to this Promotion are partially or completely lost or destroyed.
11. Participants grant the Organizer the right, in the event they participate and win prizes, to publish their name for advertising purposes, either internally or in any media and by any means, without any compensation other than the prize from the Promotion. Participants do not have, nor will they acquire, any rights over the trademarks, names, logos, symbols, or any other distinguishing marks of the Organizer.
12. These terms are governed by Greek Law. For any dispute arising from the interpretation or application of these terms, Greek Law shall apply, and the competent courts shall be those of Athens, Greece.
